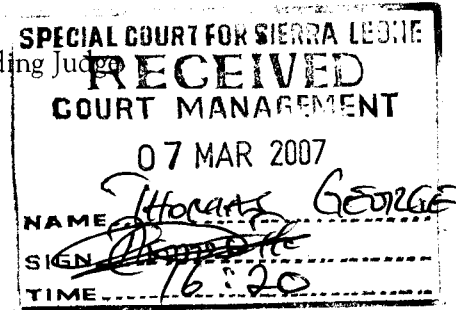

SEIZED of the Registrar's Submission Pursuant to Rule 33(B) Relating to the Death of the First Accused Samuel Hinga Norman, filed on the 6th of March 2007;

CONSIDERING that the Trial Chamber was informed of the death of the First Accused Samuel Hinga Norman on the 22nd of February 2007;

NOTING that the Registrar moves the Trial Chamber to consider this application and to take any measures that it may deem appropriate in relation to the Accused Norman's death;



CONSIDERING FURTHER that this matter requires that the Parties be provided with sufficient time in order to make their submissions;


PURSUANT TO Rules 7(C), 26bis and 54 of the Rules of Procedure and Evidence of the Special Court;
