

## **REQUEST FOR EXTENSION OF TIME TO RE-FILE FINAL TRIAL BRIEF.**

## SUBMISSIONS

Counsel for the 3<sup>rd</sup> Accused, Allieu Kondewa hereby file this motion for an extension of time within which to comply with the "Order on re-filing of Kondewa Final trial Brief" of Trial Chamber
("The Chamber") of the Special Court for Sierra Leone ("Special Court") dated the 23<sup>rd</sup> November 2006.

2. The said Order directs:

"Court appointed Counsel for the Third Accused shall re-file the Kondewa Final trial Brief and shall ensure that <u>every</u> reference to the testimony of witnesses is supported by the date and transcript page reference of the testimony in question, by 10.00 a. m. on the 24<sup>th</sup> of November, 2006".

3. It is conceded that the Final Trial Brief filed by Counsel for the 3<sup>rd</sup> Accused on the 22<sup>nd</sup> of November 2006 fails to comply materially with paragraph 5 of the Chamber's "Order for filing Final trial Briefs and Presenting Closing Arguments" of the 29<sup>th</sup> September 2006.

4. Given that at the present moment it is only one Counsel who is working on the case for the  $3^{rd}$  Accused, the other three Counsel being out of the jurisdiction on other matters and without any means of communicating with them.

4. Considering the extent of work required to fully comply with paragraph 5 of the said order which will require the review of thousands of pages of trial transcripts.

5. Counsel submits that it would be in the interest of justice to allow the additional time requested and respectfully urge the Chamber to modify the above-mentioned portion of its order to read:

"Court appointed Counsel for the Third Accused shall re-file the Kondewa Final trial Brief and shall ensure that <u>every</u> reference to the testimony of witnesses is supported by the date and transcript page reference of the testimony in question, by 1.00 p. m. on the 27<sup>th</sup> of November, 2006".
