I. INTRODUCTION

Considering the "Kanu- Request for an Order not to Disclose Photography,
Video and Audio Recording of the Trial to the Public and/or Third Parties", the
Defence on behalf of Mr. Tamba Alex Brima also respectfully seek an Order
Not to Disclose Photography, Video and Audio Recordings of the Trial to the
Public and/or Third Parties.

II. THE APPLICATION

- 2. This application is made in support of the application already filed by the Kanu Defence team. It is respectfully agreed that the identity of the alleged perpetrators of the events described in the Prosecution witness statements will become an important factor in the determination of this case. The Defence for Mr. Brima will, in due course file its pre-trial brief and preliminary motions which will outline the position in this Accused's case and, we submit, strengthen this application.
- 3. It is feared that disclosure of Mr. Brima's image could have the unfairly prejudicial effect of influencing potential witnesses before they attend the Trial Chamber to give evidence in this case. It will undoubtedly have been noted by the Chamber that no identification procedures have been put into effect as regards the Accused, Tamba Alex Brima. We support the motion put forward by the Kanu Defence team and agree with their submissions.

testimony at trial.
