PROSECUTION RESPONSE TO THE DEFENCE MOTION REQUESTING REASONS FOR PROSECUTION OBJECTION TO AUTHENTICITY OF THE EXHIBITS FILED BY ISSA SESAY

I. Introduction

- 1. Paragraph 2. e.) of the "Scheduling Order Concerning the Preparation and the Commencement of the Defence Case," states that "where possible" the Prosecution should advise whether there is any objection to the authenticity of the exhibits filed by an Accused.
- 2. The Defence for the First Accused filed an exhibit chart listing 395 exhibits (DIS/EXH/1 to DIS/EXH/395).²
- 3. The Prosecution, upon inspection of the exhibits, filed a notification of objection to the authenticity of most of the exhibits that are sought to be tendered by the Defence for the First Accused.³ Copies of the exhibits have not been given to the Prosecution but the Defence has permitted the Prosecution to inspect copies of the exhibits.
- 4. The Defence for the First Accused has filed a motion requesting reasons for the Prosecutions objection to the authenticity of the exhibits filed by the First Accused.⁴
- 5. Upon further inspection, the Prosecution advises that it does not object to the authenticity of the following additional exhibits: DIS/EXH/61, DIS/EXH/68, DIS/EXH/69, DIS/EXH/70, DIS/EXH/80, DIS/EXH82, DIS/EXH/83, DIS/EXH/85, DIS/EXH/86, DIS/EXH/134, DIS/EXH/135, DIS/EXH/138, DIS/EXH/151, DIS/EXH/157, DIS/EXH/161, DIS/EXH/271, DIS/EXH/272.
- 6. The basis for the Prosecutions objection to the remaining Exhibits is that upon inspection of the Exhibits, the Prosecution is unable to verify authenticity. The Appeals Chamber has previously decided that a statement that is unauthenticated is not necessarily unreliable, and in that particular instance held that the unauthenticated documents were relevant and should have been admitted into evidence.⁵ The Prosecution is not at this time suggesting that it will object to the admissibility of the documents listed by the
