TRIAL CHAMBER I of the Special Court for Sierra Leone composed of Hon. Justice Benjamin Mutanga Itoe, Presiding Judge, Hon. Justice Bankole Thompson, and Hon. Justice Pierre Boutet;

SEIZED of the Defence Motion for Admission of Written Evidence Pursuant to Rule 92ter filed by Counsel for the First Accused, Issa Hassan Sesay ("Defence") on the 8th of February 2008 ("Motion") in which the Defence moves for the admission of the evidence of witness DIS-015 ("Witness") in the form of a written statement;

HAVING RECEIVED the Response to the Motion filed by the Office of the Prosecutor ("Prosecution") on the 13th of February 2008 and the Corrigendum thereto filed on the 14th of February 2008;

HAVING RECEIVED the Responses to the Motion filed on behalf of the Second Accused, Morris Kallon, and the Third Accused, Augustine Gbao, on the 14th of February 2008;

RECALLING the provisions of Article 17 of the Statute of the Special Court for Sierra Leone ("Statute") and Rules 89 and 92ter of the Rules of Procedure and Evidence ("Rules");

RECALLING that Rule 92ter was adopted on the 24th of November 2006 and that this Chamber has never before had occasion to make an order relating to the admission of evidence under this provision;

RECALLING that in its Decision on Prosecution Motion for Admission of Part of the Prior Evidence of TF1-362 and TF1-371 Pursuant to Rule 92ter rendered in the case of Prosecutor v. Taylor on the 25th of January 2008, Trial Chamber II held that the agreement of the Parties is a condition precedent to admission of evidence under Rule 92ter of the Rules;

CONSIDERING that the Prosecution and the Defence Teams for the Second and Third Accused agree to the admission of the Witness' evidence in the form of a written statement and that the Prosecution declares its intention to cross-examine the Witness in Court;

PURSUANT to Rules 89 and 92ter of the Rules;

HEREBY GRANTS the Motion; and

ORDERS that the written statement of DIS-015 be admitted into evidence subject to the Witness
