- 1. The Prosecution files this application to lift the confidentiality of the Confidential and Ex Parte "Prosecution Motion for Leave to Amend the Indictment and for Approval and Non-Disclosure of the Amended Indictment" in the case of Prosecutor v Charles Taylor dated 6 March 2006, ("Confidential Motion") and the Confidential and Ex Parte Decision of the Designated Judge on the Confidential Motion dated 16 March 2006 ("Confidential Decision").
- 2. In its Confidential Motion, the Prosecutor requested that the Amended Indictment, if approved, not be disclosed to the public until it was served on the Accused or upon further order of the Court. The Designated Judge approved the Amended Indictment and made an order for non-disclosure as requested. The Amended Indictment and accompanying Case Summary were filed on 17 March 2006.
